Planner Timmerman gave the staff presentation.

Applicants discussed minor changes and the shifting of buildings east, maintaining the setback, but adding 22 parking spaces. Also added a recycling enclosure, a permanent generator and a space for a temporary generator based on experience at an additional site outside of Greenwood Village. Staff also mentioned accessible parking will be moving to the main median.

Chair Hascall opened the item for questions.

The Commission asked questions to clarify the major subdivision plat and final plat, clarifications on enclosures, and the timeline on the demolition and construction process. The Commission asked if this was similar to previous grocery projects. Planning Manager Stertz confirmed that in comparison to other grocery stores in Greenwood Village, this project is being held to a higher standard.
